## 2. Study Session - 5:00 pm

A. Annual SCC Training (State Statute) - Susan Edwards, Community Engagement Coordinator

All the schools in the District have a School Community Council (SCC), which is comprised of parents, staff, and principal. The distribution amount for Canyons LAND Trust is

\$4,865,437.00. The SCC's role includes being good stewards of the Trust and writing plans for the LAND Trust funds. The SCC also gives input and approves TSSP, school safety, digital citizenship, and safe walking routes. They also review and give input if changes are needed in positive behaviors, electronic device plans and school attendance.

The Board of Education's role is to receive, review, and approve the TSSP and LAND Trust plans for compliance with the statutory requirements of these two funding resources. The Board provides rubric guidelines with elements for SCC's to follow writing the plans and for Board members to easily review. Two board members are assigned to review and approve each school's plan by May 12, 2025.

In compliance with State statute that requires providing annual training for all SCC members, the district will be offering 3 basic training sessions and 6 general training sessions. The SCC website compliance was reviewed, and training has been conducted at every school to assist with what content needs to be on the SCC website

Canyons piloted an electronic SCC elections option at Brighton, CCHS, Butler Middle and Copperview for parents to participate. The electronic option was successful and increased participation. The recommendation is that the policy committee review and consider it for adoption as a method for all schools to use in the future. ### B. Annual Nutrition Services report - Sebasthian Varas, Director of Nutrition Services

Mr. Varas reviewed the Nutrition Services organizational chart and indicated that the department is close to being fully staffed which is helping provide better service for students. The National School Lunch Program and The National School Breakfast Program requires school lunches meet meal pattern and nutrition standards based on the latest Dietary Guidelines for Americans. State Legislation (HB222) mandates breakfast alternate models for schools with over 30% free and reduced eligibility. Breakfast in the classroom is currently provided at East Midvale Elementary, Midvalley Elementary, Copperview Elementary and Sandy Elementary. Canyons continues to provide the Seamless Summer Program, the Fresh Fruits and Vegetable Program, and the Alternate Breakfast meal service program in qualifying schools.

The Canyons Café provides breakfast and lunch for employees or patrons at the district and a catering program that provides meals for trainings or meetings held at the district office.

Nutrition services continues to provide nutrition education throughout CSD schools by having registered dietitians in the classroom, planning promotions for school cafeterias, and developing tools for distributing nutrition education in the school community. This year's motto is "School Meals are Magic."

The free and reduced lunch percentages have changed from the 2023-2024 school year from 23.51% free and 4.31% reduced, to an increase to 26.17% free and a decrease to 4.00% reduced for the 2024-2025 school year.

The Community Eligibility Provision (CEP) is a non-pricing meal service option for schools allowing to serve breakfast and lunch at no cost to all enrolled students without collecting

household applications. Qualifying schools in CSD include Copperview, Midvale, East Midvale, Midvalley, Sandy and Midvale Middle schools.

The District is experiencing an increase in school meal program debt which means at the end of the year more families are not paying the school lunch bill. Donations to pay for the negative meal accounts include donations from private donors and the District can apply for a grant to help cover student meals through the governor's office.

The Nutrition Services Department has been fiscally responsible in managing expenses which has led to a positive Nutrition Services Fund Balance equivalent to 7.5 months. Federal rule allows the District to have a positive funds balance equivalent to 3 operating months. To utilize the funds a written plan will be designed to include paying balances for students qualifying for reduced benefits, improving services for the meals program, investing in equipment renovation for the kitchens and improving labor conditions. #### 8. New Business

A. Strategic Plan Focus Group Report: Access & Opportunity – Paula Logan, Director of Federal and State Programs

The Access & Opportunity committee is focused on building bridges for all students to learn. Ms. Logan distributed a handout and reviewed the information regarding students who are served by Federal and State programs through Title I reading and math supports, Title III multi language learners, Title VI Native American learners, McKinney Vento students experiencing homeless, community schools, extended learning and teen centers.

The focus group is addressing issues by implementing multi language learner professional development for teachers around quality interactions, resources and allocations for newcomer supports, and Special Education supports such as unified sports, Life Skills Academy, and additional professional development days. Ms. Logan reviewed projects that were worked on and completed by subgroups during the summer.

During the 2024-2025 school year the focus group will instead of addressing immediate fires they will shift the focus towards developing a guiding document derived from the strategic plan. This will not only help navigate current challenges but also provide a long-term framework that aligns actions with broader organizational goals.
